2. Approval of the Minutes, CARBON2020

The Minutes of the 2020 ECA Council Meeting were sent to the national representatives by e-mail been it approved.



3. Carbon Conferences

a. UK, London, 2022

Geoff Fowler informed about the conference format, site, fees and different facilities that London city has as host, as well as that all the relevant information was already collected in the official webpage, and remembering that the abstracts submissions call was already opened. The registration fee was a topic of discussion and a bit concerning for the resto of ECA members. Geoff also expressed concern about the effect of the pandemic, estimating the number of attendees around 300. ECA members asked about the return of registrations fees in case of cancellation. Geoff informed that the degree of refund would depend on the responsible of the cancellation and the corresponding cancellation policy, specifying that if the Government were the one to cancel the event then the refund would be 100%.

b. France, 2025

France, 2025. SFEC has continued the preparation of the conference, which will be held from June 29th to July 4th. The location of this meeting was not shared.

c. Portugal, 2028

Portugal, 2028. PCG activities have not started yet as the event is still far ahead.

4. ECA Award 2022

The ECA president proposes to recirculate the rules of the award to be checked by the different members of the ECA, and to open a reflection on whether it is convenient to change / update some points. Prof. Pereira considers that it is better not to modify the rules of the award until after London. In any case, it is agreed to publish the agreed award rules in the month of April 22.
